FROM THE CHIEF EXECUTIVE OFFICER

Dear Friends and Neighbors,

There is no denying that 2021 presented us all with challenges. Yet I have always believed that it is during our most trying times that we learn our true strength, and last year I am proud to share we did just that. With the support of our community and the dedication of our partners, SafeSpot served a record number of children and families in 2021, creating safer, healthier futures for those impacted by the tragedy of physical and sexual abuse in Fairfax.



I am often asked how COVID-19 has affected child safety. While it will take researchers years, even decades to evaluate the long-term effects of the pandemic, there was never a question what the immediate results would be: <u>vulnerable children at even greater risk of abuse</u>. Yet in the first year of the pandemic, referrals for our services decreased. It wasn't until 2021, when children returned to the classroom (and everywhere else) that we began seeing the true effects of the isolation they experienced. From January - December 2021, SafeSpot received a record number of referrals from our partners in law enforcement and child protective services, resulting in a 26% increase in the number of forensic interviews provided by our team of specialists. In total, 564 children received a forensic interview through SafeSpot in 2021, and 513 caregivers were provided with crisis support, psychosocial education, and community referrals (a 15% increase over 2020). And for those at most risk of severe, long-term trauma, our therapy team provided 1,171 sessions of trauma-focused cognitive behavioral therapy.

It can be hard to find the silver lining in these numbers, as no caring individual would want to see a single child abused, let alone 564 children. And yet SafeSpot exists for the sole purpose of intervening on behalf of child victims following an allegation of abuse. When children are not seen, when they are forced to suffer alone and in silence, we lose the ability to intervene, and our partners lose the ability to hold perpetrators accountable. Can we do more as a community to prevent child abuse? Undoubtedly. But until the day we can eradicate violence and exploitation directed at children, the doors at SafeSpot's must remain wide enough to serve every child in need. By hearing and believing, supporting and advocating, we minimize trauma, facilitate healing, and invest in the long-term well-being of children and families. We stop intergenerational cycles of abuse before they have a chance to take hold. And last year we did this for more children than ever. This is the silver lining that we celebrate at SafeSpot.

While 2021 presented SafeSpot with the opportunity to serve more children and families, we expect even more growth in 2022. In the coming months, we will release the results of a year-long strategic planning process that will put SafeSpot on a path to forming new partnerships, enhancing programs, and serving even more children and families in need. I look forward to sharing this plan with each of you. In the meantime, I am excited to draw your attention to our refined mission statement on the following page. This change reflects our desire to make the work of SafeSpot, and all Children's Advocacy Centers, more understandable and engaging to the wider community. For, at the end of the day, our results are simple: healthier children, stronger families, and a safer community for all.

The mission of SafeSpot Children's Advocacy Center is to provide a safe environment and support services for child abuse victims and their families as they navigate the investigation and aftermath of abuse.

Our Vision

To reduce the trauma and improve the lives of child sexual abuse victims as they navigate the investigative, legal, and post-trauma treatment systems following an allegation of abuse.



<u>Changing the Child Welfare System</u> WHAT HAPPENS <u>TODAY</u> WHEN KIDS NEED HELP FOR ABUSE




The Forensic Interview Reducing Trauma & Paving the Way for Justice



The core service of a Children's Advocacy Center - the **forensic interview** - requires a safe, welcoming environment, highly trained interviewers, and close coordination with a multidisciplinary team that includes law enforcement, Child Protective Services, medical professionals, and prosecutors. All of these components come together at SafeSpot, where we conduct a single forensic interview that is used by the entire multidisciplinary team, ensuring children are not traumatized by having to re-live their experience(s) in multiple interviews.

SafeSpot's highly trained Forensic Interview Specialists know how to ask questions that are structured to avoid retraumatizing the child or compromising the investigation. Forensic interviews are used throughout the child abuse investigation and they become evidence in criminal trials, helping to support justice for the child, family, and community.

Family Advocacy Safety, Stability, and Support

SafeSpot Family Advocates provide parents and caregivers with crisis counseling, resources, service referrals, and guidance on navigating the child welfare and criminal justice systems. Addressing the needs of the non-offending parent or caregiver is critical, as feelings of guilt, anger, and disbelief can often follow a report of child abuse, especially when the alleged abuser is a family member or friend. Helping caregivers understand the impacts of abuse and trauma ensures the best support is given to their child, and that the remaining family unit grows stronger.



IN 2021, SAFESPOT PROVIDED FAMILY ADVOCACY TO 513 CAREGIVERS. THIS REPRESENTS A 15% INCREASE OVER 2020

97% of participating caregivers felt they knew what to expect with the situation facing their child and family after visiting SafeSpot.

91% of participating caregivers felt SafeSpot did everything it could to help their child and themselves.

99% of participating caregivers reported that SafeSpot staff provided them with resources to support their child and respond to their needs in the days and weeks ahead.

Trauma Focused Therapy Promoting Long-Term Health & Resiliency

Helping children process and recover from the pain and trauma of sexual or severe physical abuse requires specialized care. SafeSpot's Mental Health Therapists utilize Trauma-Focused Cognitive Behavioral Therapy (TF-CBT), an evidenced-based therapy tailored to the unique challenges of youth with post-traumatic stress and mood disorders resulting from abuse, violence, or grief. Over the course of 16-30 sessions, our therapists work with survivors to build coping strategies, reduce symptoms of depression and anxiety, address negative behaviors such as distorted thinking and low self-esteem, and regain the ability to form trusting, healthy relationships. Caregivers are also active participants in their child's therapy. Through individual and joint sessions our therapists help family members cope effectively with their own emotional distress and develop skills that support their children.



The Multidisciplinary Team: A Coordinated Response

The Multidisciplinary Team (MDT) model is the foundation on which a Children's Advocacy Center operates. This innovative approach recognizes that in order for communities to effectively respond to child abuse, a true public-private partnership is essential. As facilitators of Fairfax County's MDT, SafeSpot brings together the many agencies and departments responsible for the protection of children, ensuring a united effort to respond. Fairfax County's MDT includes the Fairfax County and City Police, Herndon Police, Victim Services, Child Protective Services, the Office of the Commonwealth's Attorney, Fairfax County Public Schools, and the medical professionals at the Inova Ewing Forensic Assessment and Consultation Team. Our thanks go out to each team member who joins with SafeSpot in making our community safer for all children.





Meet Ayana and her Family

Ayana means "beautiful flower" in Swahili.

Ayana's parents, Christine and Shawn, met in 2012 while they were stationed in South Sudan through the Peace Corp. Eager to start a family, and wanting to provide a loving, safe home to children orphaned by the violence of war, Christine and Shawn adopted Ayana, Namir, Leila, and Tabby, all children who had lost their parents in the civil conflict. The blended family took some time to adjust and bond, but after a few years Ayana and her brother and sisters became as close as any biological siblings. And when their parents returned to the states to settle the family in Northern Virginia, the children embraced everything their new home had to offer.

When Leila and Tabby, the oldest siblings, went away to attend college two years ago, 9-year-old Ayana and her 14-year-old brother Namir became closer than ever, preferring to spend their time almost exclusively with one another. While Christine and Shawn were happy that the two younger children were so close, they started noticing some disturbing behavior. One day, Christine entered Ayana's room and found her and Namir engaged in oral sex.

Christine and Shawn struggled with what to do next, but they knew they had to protect both of their children and decided the best thing to do was to call Child Protective Services (CPS). It was a painful decision, but one they knew they had to make for their family.

CPS engaged law enforcement and referred Ayana to SafeSpot for a forensic interview. During the interview, Ayana revealed that what had started with inappropriate touching and pornography had escalated over the past several months to sexual acts.

Working together to support the distraught family, SafeSpot's Family Advocate, law enforcement, CPS, and the Office of the Commonwealth's Attorney helped Christine and Shawn make the difficult decision to send Namir to a residential program where he could get the best possible treatment for his problematic sexual behavior. At the same time Ayana would remain safe at home and begin trauma-focused cognitive behavioral therapy (TF-CBT) with a SafeSpot mental health therapist. Christine and Shawn told both of their children that they were loved, and that neither would be abandoned - a fear they retained since losing their biological parents. They asked Namir and Ayana to commit to their treatment, and promised that when it was safe for them both, they would once again be together as a family.

While in treatment, Namir revealed that he had been sexually assaulted multiple times by older children at the Sudanese orphanage where he grew up. Without the intervention of caring adults, Namir had internalized his experience and came to believe that it was appropriate to show love and affection through sexual intimacy.

At SafeSpot, Ayana struggled at first to understand why her brother's behavior was wrong. Because she loved her brother and the abuse "felt good", she couldn't rationalize the reaction of her parents and other adults around her. She blamed herself for Namir's separation from the family and her old siblings' anger towards him. She was confused, and she missed her best friend.

Over the course of 11 months, both Namir and Ayana came to understand why their sexual relationship was harmful and how their past experiences had shaped their distorted view of love and affection. They each addressed their individual trauma and learned what healthy relationships between siblings and family members look like.

In December of last year, Ayana's SafeSpot therapist, Namir's treatment coordinator, and Christine and Shawn began a series of reunification sessions. A safety plan was developed that included no physical contact or unsupervised time together. After four sessions, Ayana and Namir's older siblings were invited to share their feelings and to show their support for their brother and sister. In their last session, Namir presented Ayana with several drawings he had created for her and when Ayana went to hug him, he told her that because he loved her, he couldn't hug her - but that he could give her a high-five! He went on to thank her for telling the truth and getting him the help he needed to be the brother she and her siblings deserved.



SafeSpot in the Community


