Letter from the CEO



Dear Friends and Neighbors,

As we end 2023 and reflect on this year's triumph, I couldn't help but look to the future. One quote came to mind by award-winning author Richie Norton, who said, "Every sunset is an opportunity to reset. Every sunrise begins with new eyes." We will celebrate the success of 2023 and look to 2024 refreshed and in a new light, knowing the future will be even brighter. We know that none of this would be possible without the support and commitment from our donors and volunteers.

2023 marked the second year of our strategic plan, which focuses on strengthening our services and reaching even more children and families impacted by abuse in Fairfax County. This past year, our programs served 650 children and 558 caregivers. SafeSpot facilitated 2 new support groups for our caregivers and teens. The Caregiver Support Group provides nonoffending caregivers with a forum to network, gain education about the effects of abuse and trauma on their child/ren, and process their own complex feelings and emotions. The Teen Support Group provides teen girls with a safe place to discuss their experiences and participate in activities promoting self-care, positive thinking, and healthy relationships.

In an effort to grow our multidisciplinary team, SafeSpot built partnerships with the Criminal Investigation Division and Family Advocacy Program at Ft. Belvoir to ensure children living on the military base have direct access to SafeSpot. This partnership resulted in a 200% increase in forensic interview referrals from Ft. Belvoir from 2022 to 2023.

Our therapy team had a busy year as SafeSpot therapists were trained and certified in a new, evidence-based therapy treatment called Child and Family Traumatic Stress Intervention (CFTSI). The treatment, developed by the Yale Center for Traumatic Stress and Recovery, is an early, short-term intervention for children and adolescents aged 7-18 in the wake of disclosure of physical and sexual abuse with the goal of reducing symptoms and preventing the onset of posttraumatic stress disorder (PTSD). Over the course of 5-8 sessions, therapists work with the child and their caregiver to raise awareness of trauma symptoms, improve communication, and develop skills to help master trauma reactions. By adding this treatment option to our menu of therapeutic services, we can better adapt to the differing needs of the children we serve so they have the best possible outcomes.

Finally, SafeSpot received our 5-year reaccreditation from the National Children's Alliance (NCA). The NCA ensures that all Children's Advocacy Centers (CACs) across the U.S. provide consistent, evidence-based services to help children heal from abuse. SafeSpot's reaccreditation demonstrates that our programs and services meet the rigorous standards as developed by more than 130 child abuse intervention professionals and experts following the latest evidence. We are proud to have renewed this accreditation for the next 5 years!

This year's success wouldn't have been possible without your support and generosity. On behalf of myself, our Board of Directors, staff, and everyone we serve, I thank you for your gifts of compassion, continued dedication to our mission, and the positive impact you make on the lives of children and families in Fairfax County. I look forward to another exceptional year ahead!

FORENSIC INTERVIEWING

- Forensic Interviews were conducted by a highly trained child interview specialists to assess safety, gather evidence, and support justice and community safety.
 - 94% of children surveyed reported that Center staff were helpful, or very helpful in making them feel safe.
 - of children surveyed reported that Center staff were good or very good at listening to them.

FAMILY ADVOCACY

- Nonoffending caregivers received advocacy services including crisis counseling, community resource referrals, and guidance on how best to support their child(ren).
 - 94% of caregivers surveyed agreed that they knew what to expect with the situation facing their child and family after visiting SafeSpot.
 - of caregivers surveyed reported that SafeSpot staff provided 100% them with resources to support their child and respond to their needs in the days and weeks ahead.
 - 95% of caregivers surveyed agreed that SafeSpot did everything it could to help their child and themselves.

MENTAL HEALTH THERAPY

- 102 Children received trauma-focused therapy to reduce symptoms of depression and anxiety, address negative behaviors, build coping strategies, and regain the ability to form trusting, healthy relationships.
 - of children who completed therapy in 2023 demonstrated a decrease in trauma-related symptoms.
 - booster sessions were provided to children who needed additional support post-graduation.

MULTIDISCIPLINARY TEAM

Member agencies of the Fairfax County Child Abuse Multidisciplinary Team (MDT). Close coordination with our partners ensures each child and family receives wrap-around services that reduce trauma and prioritize safety and healing.

10-year-old Kayla lives with her 6-year-old sister Tiffany and their mother Carly. She loves art, video games, and playing with her German Shepherd Pizza. This year, Kayla joined the school band and is learning to play the clarinet. But her absolute favorite thing, by far, is being a big sister to Tiffany.

In fall of 2023, Kayla was brought to SafeSpot for a forensic interview after confiding to her mother that her father was touching her in a way that made her feel uncomfortable.

While talking to the forensic interviewer, Kayla disclosed that her father had been physically and sexually abusing her for over a year. She was only able to overcome her fear and tell her mother because she was worried that Tiffany would become his next victim. After learning of the abuse Kayla faced, Tiffany was brought to SafeSpot for a precautionary forensic interview, though no indication of abuse was found. While observing both interviews, law enforcement was able to gather enough information to successfully petition the court for an emergency protective order to keep Kayla and Tiffany safe, and to begin the criminal investigation.

When Carly met with the SafeSpot family advocate, she expressed feelings of anger and sorrow, as well as guilt for allowing Kayla and Tiffany to have unsupervised visitations with their father. Carly had been struggling since divorcing their father the previous year, and now felt like their world was falling apart. While she wanted to be strong for her girls, she didn't have the resources to know how. Immediately, the SafeSpot family advocate began working on a plan to support Carly so she could support Kayla and Tiffany. Carly's first concern was finding safe after-school care for the girls as her work schedule prevented her from being home and she was fearful their father would defy the protective order if they were left with a babysitter. While working with our partners in the school system, the advocate was able to get Kayla and Tiffany enrolled in the School Age Child Care (SACC) Program where they could enjoy painting and other activities while Carly was at work.

Carly was placed in SafeSpot's new Caregiver Support Group where she was able to express her own feelings, connect with parents going through similar situations, and learn skills and strategies to best support Kayla and Tiffany. The entire family also received numerous holiday gifts, thanks to our generous donors, by participating in SafeSpot's Winter Wishes program.




As Carly was working with the advocate, Kayla began meeting with a SafeSpot therapist. The therapist began by conducting a mental health assessment, which showed that Kayla was demonstrating very high trauma-related symptoms and would therefore most benefit from trauma focused cognitive behavioral therapy (TF-CBT). Over the course of several months, Kayla and her therapist worked to address the invasive thoughts of guilt, fear, and anger that were dominating her waking and sleeping mind, and to re-organize her thinking in a healthier and happier way. Kayla loved starting each session with a cup of hot chocolate, practicing deep breathing with her therapist to the comforting smells of mint and cocoa. As the sessions progressed, Kayla learned that the abuse was not her fault, nor had she been powerless; in fact, she had been powerful by coming forward to help herself and her sister.



Carly has been an active participant in her daughter's care, checking in with the therapist after each session and practicing the new skills and communication techniques she has built through the support group. Together with their therapist, Carly and Kayla have also been learning how to talk with Tiffany about what happened in a way that makes her feel safe and loved. While they continue to work on their path of healing, their future looks hopeful and bright.


