Director's Message

September is upon us and that means cooler weather, school buses and fall foliage. It also means that SafeSpot is busier than ever! With children attending school, our agency typically sees an increase in referrals. We are grateful to those caring community members who report child abuse and strive to keep children safe from harm.

In order to meet this annual rise in demand, our program needed additional forensic interviewers and longer office hours. While the SafeSpot team was busy working on a number of solutions, one direct path towards obtaining these goals was to secure additional grant money. And that is exactly what we did! The Virginia Department of Social Services grant increase allowed us to hire a second, full-time forensic interviewer and a part-time receptionist. Conducting interviews later in the evening is now a reality and a tremendous help to local law enforcement and social workers.

An increase in awareness was also at the forefront of our summer task list! Since forensic interviewing and mental health services are integral pieces in the well being of children who have witnessed domestic violence, our center focused on making this better known. As members of the Fairfax County "Step Up 4 Kids" committee, SafeSpot is able to do just this! Sitting on a committee solely dedicated to young witnesses of such violence, allows us to reach the right service provider ears.

Our SafeSpot voice continues to broaden as our center continues to expand and evolve.



BOARD MEMBER KRIS DEBYE PROPOSES EXPANDING VIRGINIA CODE TO PROTECT MORE CHILDREN

SafeSpot Board member Kristina Debye is a former Director of the Baltimore County Children's Advocacy Center. Her knowledge of Maryland laws that protect children from abuse prompted her to look into similar laws in Virginia. When Kris learned that individuals living in a home but not designed as a "caregiver" are not covered by Virginia law, she met with members of the Commonwealth Attorney's office to draft a legislative proposal that might close this loophole. The state chapter of Children's Advocacy Centers (CACVA) is considering making the proposed legislation part of its advocacy efforts during the 2020 General Assembly session. Thank you, Kris, for doing all you can to strengthen the protection of children in Virginia!
