Charlie retired from the FBI after serving as a Special Agent for more than 28 years. An expert in interviews and interrogations, Charlie obtained confessions that resulted in the convictions of a

wide-variety of subjects, including three sitting members of Congress, numerous corporate executives, and a spy. He received the FBI Director's Award for Excellence in HUMINT (human intelligence), the bureau's highest award, for interviews/interrogations he conducted on classified national security matters while deployed to Afghanistan. After retiring from the FBI, Charlie created and led a corporate investigations practice at a consulting firm, was the Chief Security Officer of a Fortune 500 company, and served as the Chief Strategy Officer of a privately-held company that owns and manages over \$4 billion in real estate.

## FBI Recognizes Angela Haslett, SafeSpot's Manager of Forensic Services



On March 22nd, the FBI Washington Field Office named Angela Haslett as the Recipient of a 2023 FBI Director's Community Leadership Award! Assistant Director in Charge David Sundberg presented the award in recognition of Haslett's work as SafeSpot's child forensic interviewer for the Washington Field Office's (WFO) Child Exploitation and Human Trafficking Task Force (CEHTF), which has helped mitigate crimes against children – particularly crimes involving victims of sextortion.

*"We recognize Angela Haslett today for her tireless work in supporting the young victims of some of the most heinous crimes imaginable," Sundberg said. "There is no doubt her work has reduced the trauma experienced by victims and has assisted in our ability to put offenders behind bars," said Sundberg during a live interview on ABC 7News.*

Haslett and other SafeSpot employees lead multidisciplinary teams through investigations, reviewing and ensuring each case is moving carefully and efficiently through the therapeutic, investigative, and prosecutorial processes. Haslett's work has reduced the trauma experienced by child victims; improved prosecution outcomes; and provided efficient, compassionate, and thorough no-cost services to child victims and non-offending family members.
